

SHOW EMERGENCY BACKUP

CEC Show and 3 Stage Show

In the event that your show VCR fails, the CEC Show and 3 Stage Show have an Emergency backup tape. The diagram below instructs you how to connect a Hi Fi Stereo VCR to play the 60 Minute Emergency Backup Tape (CEC Show Part # CS-0053-A, 3-Stage Show Part # CS-0053). It must be a Hi Fi Stereo VCR or this will not work.



Studio C

Studio C has an emergency backup in the event of a hard drive failure. If your Studio C computer where to suffer a hard drive failure or you receive a message that informs you of a bad or missing file, it is still possible to run your show from your 3.5" floppy drive. All stores with Studio C should have the Emergency backup show that consists of Chuck E's Variety Show DVDs and a bootable floppy labeled Studio C Emergency Backup (part # STC-CRASH no charge, limited one per location).
